Completing and filing the annual Form 990 with the IRS is a requirement for certain tax-exempt organizations, It provides the IRS with information about your nonprofit's activities and financial status to demonstrate that it continues to meet the qualifications for tax-exemption. The form is also reviewed by potential donors and grantors to learn about an organization's mission, programs and finances.

This webinar will teach participants how to complete the IRS Form 990 by detailing the following:

- Which revenues and expenses to report
- Fundraising costs to be included
- Statement of accomplishments
- Which members of the organization to list
- How to conduct a board review of your Form 990
